Report on National Webinar on

“Matrimonial Remedies in India: An Overview” on 31st July 2021

Marriage is an organization of two people who come together as promised to live together. Every religion is confidently believes that marriage is the union of woman and man forever. However, in order to provide relief to a distressed spouse, the law provides some marital solutions in almost all countries of the world. Statutory law revolves around four basic areas of marital release - annulment of marriage, restoration of marital rights, judicial separation, and divorce. To enrich and share knowledge on the above topic, the college Women Development Cell joined with IQAC organized a webinar on the theme of "Matrimonial Remedies in India: An Overview" dated 31st July 2021.

We circulated the registration link online and received an auspicious number of registrations in a limited period of time. There were no registration fees. Participants in the webinar include law students, professors, librarians, and law professionals. We got responses all over India. The program was conducted on Zoom Platform and live YouTube Channel. The webinar session started with some important instructions to carry out the event in a smooth manner.

Our respected IQAC Co-ordinator, Asst. Prof. Amar Salave, welcomed all the dignitaries and gave an introductory speech on the theme of the webinar. Further our hon'ble principal Dr. Madhura Kalamkar Madam felicitated the guest speaker by giving her brief introduction. The guest speaker of the webinar was –**Dr. A.G. Farswani, Principal Judge, Family Court, Thane.**

The hon'ble guest speaker began by introducing the theme of “Matrimonial Remedies”. Madam has laid special emphasis on covering all CrpC and IPC sections in the context of marriage, maintenance, and Divorce by explaining the related landmarks cases/judgments. Madam also emphasized the Domestic violence Act, where the two cases are described in detail - Indra Sharma vs V.K.V. Sharma (2013) 2 SC 137 and D. Velusamy vs. d. Patchaiammal (2010) 10 SCC 469).Also explained S.20 Monetary relief under the act. Also the Hindu Adoption and Maintenance Act, 1956 are briefly highlighted.

Furthered Madam has covered all laws related to the subject which includes Hindu Marriage Act, 1955; Special Marriage Act, 1954; Indian Divorce Act, 1969; Parsi Marriage and Divorce Act, 1936. Muslim Women (Protection of Rights on Marriage) Act, 2019.

Also explained the various concept comes under matrimonial remedies such as cruelty, adultery, Conversion to other religion, Dissolution of Marriage (Hindu, Parasi, and Muslim); Alumina and Maintenance; and Conjugal Rights or Judicial Separation.
