#### National Webinar on "Ukraine-Russia Crisis & Public International Law"-26th March 2022

The conflict between Ukraine and Russia has entered a month since Putin waged an offence on the Ukraine country. Looking at their past rocky relations due to the interference of NATO, the world has witnessed a threat to world peace as seen during the World Wars. This crisis has altered the power distribution in international relations and is paving the way for a new era in the course of international politics. It has raised questions of respect for humanitarian law and doubts over the effectiveness of the United Nations.

The Internal Quality Assurance Cell (IQAC) & Library Committee of Hindi Vidya Prachar Samiti's College of Law organized a National Webinar on the topic "Ukraine-Russia Crisis & Public International Law" on 26<sup>th</sup> March 2022 at 9:00 AM. We received 246 registrations via the Zoom Registration Form from law practitioners, teaching faculty and students all over the country. The webinar began with the opening address by Event Coordinator Asst. Prof. Gretta Castelino. Bhoomika Mandal (Student of F.Y.B.L.S./LL.B) read out a brief profile of the Speaker. Principal Madam Dr. (Mrs.) Madhura Kalamkar addressed the crowd graciously by tracing the history of key international relations and a well-structured analysis of India's strategic positioning on the world map and in the balance of power.

The esteemed Guest Speaker was Dr. Aradhana Talwar (Lead- Academics & Curriculum, Dalham Learning). She has written for Financial Express focusing on West and South Asia and also been part of panel discussions of regional TV news channel Gujarat Samachar TV. She explained the term International Law and its effectiveness vis-à-vis the Ukraine-Russia crisis. Madam also traced the international relations since the past seven decades to lay the context of the power dynamics. She expressed optimism against the fear of a full-blown World War III and faith in the United Nations as a body to maintain world peace.


