Report on Research Methodology

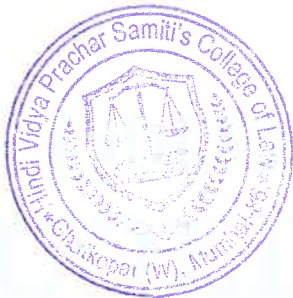
