	English	- The syllabus could be reduced by 20%  -A question on 'Question Tag' consistently appears despite not being prescribed in the syllabus. Testing them out of the syllabus should be avoided completely.  -Instead of extracts from multiple texts, complete novels/plays could be added which will help students understand the text more clearly.  - Students should be only tested on the extracts given in the prescribed book (given in the syllabus)
	Logic-I	Module 1: Analogy (1.9) to be removed and Circumstantial evidence to be included in Induction (1.8) -Module 2: Needs no changes -Module 3: Other immediate inferences (3.4) to be removed -Module 4: Introduction to Wigmorean analysis to be removed The revised syllabus was very aptly framed but it has become too heavy for the students, since Semester 1 is very short due to delay in the admission process of the students that happens every year. Since the term can't be extended, the syllabus needs to be cut down.

This makes it difficult for the students to understand the rationale behind studying them The paper pattern prescribed in the syllabus should be followed Students should be only tested on the extracts given in the prescribed book (given in syllabus)
	Logic - II	-Module 1: Needs no changesModule 2: Hypothesis (2.5), Hypothetico-deductive method (2.6) and Method inquiry (2.7) to be removed and replaced with Decision Procedure (Direct proof) as the students will learn the application of rules of inference and replacement. The students—can be taught to convert long sentential arguments into symbolic form and then apply the Direct Proof methodModule 3: Needs no changes -Module 4: Equality and its implication (4.3) and Ends and means (4.4) to be removed.
		Other than the prescribed changes, the syllabus is excellent but since it was expanded last year, the teachers need more time for completion of the syllabus and to thoroughly justify it. Despite being in Semester 4, Logic II and other subjects of Semester 4 get only 1.5 to 2 months (excluding college events and public holidays). The Semester 3 exams need to be conducted in November or December so that Semester 4 gets an ample amount of time.
	Political Science -	The syllabus could be decreased by a minimum of 20%. The scope of Module 4 is extensive. Module 4.2: The International Organizations and Specialized Agencies have the potential to be decreased.
